Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, including changes to these policies, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. The Form HUD-50075-HCV is to be completed annually by **HCV-Only PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, High Performer PHA, Small PHA, or Qualified PHA do not need to submit this form. Where applicable, separate Annual PHA Plan forms are available for each of these types of PHAs.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

B.3	<p>Progress Report.</p> <p>Provide a description of the PHA’s progress in meeting its Mission and Goals described in its 5-Year PHA Plan.</p> <p>Progress in Meeting Mission and Goals. The Tuscarawas MHA has consistently assisted eligible families with safe, decent, and affordable housing, without discrimination while adhering to Federal laws, HUD regulation, and budgetary constraints. TMHA continues to be involved with local “Continuum of Care Programs” as contracted service provider to the grantee (Tuscarawas County Board of Alcohol, Drug Addiction and Mental Health Services) of housing activities. TMHA has previously administered, as a contracted service provider, funding through 3 local CHIPs for Tenant Based Rental Assistance (TBRA) activities. Two local CHIP grantees have indicated that they will again include TBRA activities in their applications.</p> <p>TMHA continued to serve new families from its waiting list throughout the year, while at the same time maintaining assistance to those families already participating in the Section 8 HCV program. Families are assisted in units from all parts of the Tuscarawas County. In order to maximize the number of units available to participating families, TMHA has recruited new landlords each year, and has maintained open communication with landlords who need assistance to understand HUD regulation regarding Housing Quality Standards and Lead-based Paint regulations. TMHA continues to loan its HEPA Vacuum to landlords and other residents who have need of it.</p> <p>TMHA has an active HCV Homeownership Program, with two families who continue to maintain homeownership. TMHA also maintains an active Family Self Sufficiency program (FSS), and has consistently maintained enough active families to warrant a full-time FSS Coordinator. There are currently 54 families enrolled in TMHA’s FSS program. In the past year 3 participants have successfully completed contracts of participation and graduated from the program.</p> <p>TMHA actively fosters collaboration with local agencies and non-profit organizations whose clients can benefit from our voucher program. To this end, TMHA is a member of the Housing, Opportunities, Monitoring, Education (HOME) Network (which is the local Continuum of Care collaborative), and the Ohio Coalition on Homelessness and Housing in Ohio (COHHIO). In addition, TMHA staff actively cultivate an “open line” style of communication with other area agencies that serve shared clientele in order to minimize barriers in serving those in need. TMHA participates with the County and local cities by serving on local Housing Advisory Committees that formulate the jurisdictions’ Community Housing Improvement Surveys (CHIS) and the Impediments to Fair Housing needs priority surveys. In the above ways, TMHA has earned a reputation as being a respected and accountable community resource for housing for low-income families.</p> <p>TMHA has also maintained active participation with the Ohio Housing Authorities Conference. TMHA staff attend OHAC sponsored training when possible in order to remain current with assisted housing regulations and best practices.</p> <p>On its FYE 2019 SEMAP submission, TMHA earned a Standard Performer designation from HUD. TMHA will strive to meet all the expectations required of us under each of the applicable SEMAP Indicators to regain High Performer status.</p>

Until such time as the PHA is required to submit an AFH, the PHA will not have to complete section D., nevertheless, the PHA will address its obligation to affirmatively further fair housing in part by fulfilling the requirements at 24 CFR 903.7(o)(3) enacted prior to August 17, 2015, which means that it examines its own programs or proposed programs; identifies any impediments to fair housing choice within those programs; addresses those impediments in a reasonable fashion in view of the resources available; works with local jurisdictions to implement any of the jurisdiction’s initiatives to affirmatively further fair housing that require the PHA’s involvement; and maintain records reflecting these analyses and actions. Furthermore, under Section 5A(d)(15) of the U.S. Housing Act of 1937, as amended, a PHA must submit a civil rights certification with its Annual PHA Plan, which is described at 24 CFR 903.7(o)(1) except for qualified PHAs who submit the Form HUD-50077-CR as a standalone document.
